About this course

Introduction

This MRes draws on the nationally and internationally recognised expertise of staff in the Department of Sociology, Social Policy and Criminology. Over the past five years, our research has shaped criminal justice policy, improved auditing practices in public bodies and helped set best practice in evaluating large-scale arts and cultural programmes.

The programme prepares you to specialise in criminological research and develop advanced skills in studying crime-related topics. You will undertake a substantial independent research project, closely supervised by a leading scholar in their field. This experience is valuable whether you're preparing for a career, PhD study or seeking continuous professional development.

Graduates are well placed for a wide variety of careers across national and local Government, commercial research, charitable, public or private sectors. Regional Development Agencies have noted the rapid rise in demand for graduates who qualify in the full spectrum of research design and analysis techniques, skills that your will develop throughout the MRes.

Who is this course for?

This MRes is suitable for graduates from the Social Sciences or related areas who want advanced theoretical and practical training in postgraduate-level research.

- A critical understanding of epistemological, methodological and ethical approaches in criminological research
- Training in general research skills

Semester one

This programme consists of 60 credits of taught modules and a 30,000 word dissertation worth 120 credits.

The process of preparing the dissertation, including developing a research question and proposal, will take place throughout semester 1 and 2. Your dissertation will be submitted in semester 3.

Teaching and assessment

How you'll learn

Teaching is delivered in an interactive, participatory and inclusive way, with extensive support of small group teaching and online learning platforms. You'll have a mix of lectures, large group seminars/tutorials, small group workshops, one to one tutorials and research supervision meetings.

How you're assessed

You will study 60 credits of taught modules and complete a dissertation worth 120 credits.

Each of the taught modules is formally assessed by coursework on a semester basis. Depending on the learning objectives of the module, this may include project work, fieldwork analysis, a research strategy document, a report of research observation, a book review or the completion and analysis of interviews.

Your advanced criminological research project will be assessed coursework through a 30,000 word dissertation.

Tuition fees

International fees

- You can pay your tuition fees in instalments.
- All or part of your tuition fees can be <u>funded by external sponsorship</u>.
- International applicants who accept an offer of a place will need to <u>pay a</u> <u>tuition fee deposit</u>.

If you're a UK national, or have settled status in the UK, you may be eligible to apply for a Postgraduate Loan worth up to £12,167 to help with course fees and living costs. **Learn more about paying for your studies**.

Entry requirements

The qualifications and exam results you'll need to apply for this course.

Postgraduate entry requirements

We accept a 2:2 honours degree from a UK university, or an equivalent academic qualification from a similar non-UK institution. This degree should be in a social science, or in a field relevant to the programme.

All applicants are required to supply: a completed application form, proof of qualifications and two references (one of which, as a minimum, must be academic). Applicants are considered on the basis of academic ability and potential and other relevant considerations are also taken into account. Applicants who have marginally missed the benchmark indicated above, are considered on a discretionary basis.

International qualifications

Select your country or region to view specific entry requirements.

If you hold a bachelor's degree or equivalent, but don't meet our entry requirements, a Pre-Master's can help you gain a place. This specialist preparation course for postgraduate study is offered on campus at the **University of Liverpool International College**, in partnership with Kaplan International Pathways. Although there's no direct Pre-Master's route to this MRes, completing a Pre-Master's pathway can guarantee you a place on many other postgraduate courses at The University of Liverpool.

English language requirements

You'll need to demonstrate competence in the use of English language, unless you're from a <u>majority English speaking country</u>.

We accept a variety of <u>international language tests</u> and <u>country-</u> specific qualifications. International applicants who do not meet the minimum required standard of English language can complete one of our <u>Pre-Sessional English courses</u> to achieve the required level.
