# Who is this course for?

If you want to kick-start your career in football management or up your game in the sports business, this programme is for you!

Many of our candidates who join the FIMBA come from other sectors but have a lifelong passion and ambition to work in the game or start their new business within the football industry.

Typically, you will have a minimum of 3 plus years work experience in a professional or managerial capacity. Those who do not hold a degree or the required degree classification yet have extensive professional experience (more than 5 years) and/or a postgraduate qualification are encouraged to apply. ### Essential information about this course

This is a part time, online course for 24 months, offering the flexibility to study in your own time, from anywhere in the world.

- There will be a minimum of 15-20 hours of study per week
- Approximately two hours of this time will involve attending live sessions with your module lead and fellow students. The remaining time is for asynchronous (recorded) sessions, and associated study, that can be completed in your own time around your personal commitments.
- Wherever you can get an internet connection, you'll be able to study.
- There are 12 modules to complete over 24 months. The curriculum combines core
   MBA modules alongside specialist football modules focused on the industry.
- Each module runs for 6 weeks with an assessment at the end of each module.
- Two weeks prior to the start of each module, you will receive the information you need to complete it, including the dates and times of live sessions.
- Times of the live sessions will vary and efforts will be made to account for the different time zones within which students are located.
- Currently there are no planned weekend live sessions but if this changes, your Director of Studies will make you aware.
- You will have access to a complete set of online learning materials via our learning platform, <u>Canvas</u>. These materials contain the essential teaching you will need to complete your course and undertake your assessments. You will also be able to connect with your fellow students and the academic team via an online forum.
- Assessments will be carried out in your virtual classroom and may include report writing, reflective practice, research projects, and individual or group presentations.
- To help with independent study, we will provide access to our library's electronic resources 24/7, including thousands of books, ejournals and newspapers.
- <u>Chris Barlow</u>, your Director of Studies will be your key contact before and during your course. Chris will offer individual monthly meetings to answer any questions and check on your progress. Chris will also be available for questions via the platform, social media and email.

# How you'll learn

### **Teaching and assessment**

The learning, teaching and assessment strategies for all online programmes are aligned with the three University of Liverpool hallmarks of research-connected teaching, active learning and authentic assessment – as well as the three University of Liverpool Graduate attributes of confidence, digital fluency and global citizenship.

You'll take modules totalling 120 credits, with the dissertation or consultancy based project completed at the end of your studies being worth 60 credits. You'll be supported by your academic supervisor during the dissertation or consultancy based project.

You're required to complete 180 credits to achieve a full MBA. Subject to meeting specific criteria outlined by the University, you'll graduate with a Pass, Merit or Distinction.

### How you'll study

Studying online allows you to study in your own time and from wherever works best for you – whether that is from your home, during your lunch hour or anywhere else you have internet access.

With online FIMBA, you can study in your time and wherever through live and recorded sessions. All our online programmes are delivered through <u>Canvas</u>, the University's Virtual Learning Environment, enabling you to thrive in a flexible and engaging hybrid approach.

### Key features include:

- User-friendly interface accessible on smartphones, tablets, and computers
- Comprehensive course content with multimedia materials
- Interactive tools for collaboration and discussion
- Real-time feedback and progress tracking
- Mobile app for on-the-go learning

Canvas provides a flexible, engaging learning environment that combines the benefits of online study with the interactivity of traditional classrooms.

### **Assessments**

Assessments will reflect the University's hallmark of authentic assessment, which may include report writing, reflective practice, research projects, individual or group presentations and a business simulation exercise that each represent the kinds of tasks you would be expected to undertake in a professional setting. There is also one exam (delivered online) within the Managing Financial Resources module.

The weighting of individual components will vary from one module to another. All assessment information is included within the module handbook at the start of each module.

### Online learning experience

We will support your online learning experience with high-quality learning materials and resources, which can all be found on Canvas.

Typically, your learning experience will include the following:

- directed learning including participation in virtual discussions with peers, led by the lecturer, working through relevant and specially prepared videos and lecturecasts; completing interactive exercises on the learning platform; and appointments with your lecturer during office hours
- **self-directed learning** including wider reading and research in your subject area to further develop your knowledge and understanding
- **assessment** time taken to prepare and complete assignments and activities which contribute to your overall assessment.

On average, you will need to dedicate a minimum of 15-20 hours of study per module, per week.

# Fees and funding

Your tuition fees, funding your studies, and other costs to consider.

### **Tuition fees**

# UK fees (applies to Channel Islands, Isle of Man and Republic of Ireland)

### International fees

Part-time place, per year - £17,750

Tuition fees are for the academic year 2026/27. Please note, the fee for this course includes one international study trip to a European destination, including accommodation and excursions. The fee does not include any additional costs associated with the trip, such as flights and visa applications. The School cannot guarantee that visa applications connected with the study trip will be successful. Fees will not be refunded to students who do not participate in the international study trip.

Tuition fees cover the cost of your teaching and assessment, operating facilities such as libraries, IT equipment, and access to academic and personal support.

- You can pay your tuition fees in instalments.
- All or part of your tuition fees can be <u>funded by external sponsorship</u>.
- International applicants who accept an offer of a place will need to <u>pay a</u> tuition fee deposit.

If you're a UK national, or have settled status in the UK, you may be eligible to apply for a Postgraduate Loan worth up to £12,167 to help with course fees and living costs. **Learn more about paying for your studies**.

# **Entry requirements**

# **Professional experience**

MBA Candidates are normally expected to have a minimum of 3 years' work experience in a professional or managerial capacity.

This should be evidenced by providing a copy of your current CV detailing your experience and achievements to date (this may include examples of key projects, managerial responsibilities, or leadership). Please ensure that you include dates of employment and job titles on your CV.

Preference will be given to those who can demonstrate that they have strong business and management experience.

# **Qualifications**

Candidates will normally be expected to hold a 2:1 Honours degree (which may be in any discipline) from a UK university, or an equivalent professional qualification from a similar non-UK institution.

Non-graduates who possess extensive professional experience (more than 5 years) and/or a postgraduate qualification are encouraged to apply.

### Non standard entry

Non standard entry relates to applicants who may not hold a degree or the required degree classification, but may have appropriate experience. We would still encourage applications if you have:

- Significant work experience (more than 5 years)
- No formal university degree
- Substantial record of achievement in business and leadership (for example accredited training courses, learning and development courses).

Each application is considered on a case-by-case basis and will include an informal, online interview with the MBA team. The interview is an opportunity to discuss your suitability for the MBA programme, as well as your experience and interest in the MBA programme.

### Personal statement

The personal statement encourages applicants to write around 200 words for each of the following sections:

- Your reason for choosing to apply for an MBA programme
- Your reasons for choosing this particular programme
- Your future aims or career plan
- How the programme of study enables you to achieve this.

### **GMAT** score

A GMAT score is not a mandatory requirement; however, we do encourage candidates who have undertaken the examination to submit their scores for consideration alongside other criteria during the admissions process.

We look for a balanced score across all components of the GMAT and will only accept scores which are still valid (attained within the last 5 years) by the time of entry to the programme.

### International qualifications

Select your country or region to view specific entry requirements.

Many countries have a different education system to that of the UK, meaning your qualifications may not meet our entry requirements. Completing your Foundation Certificate, such as that offered by the <u>University of Liverpool International College</u>, means you're guaranteed a place on your chosen course.

# **English language requirements**

You'll need to demonstrate competence in the use of English language, unless you're from a <u>majority English speaking country</u>.

We accept a variety of international language tests and country-specific qualifications.

International applicants who do not meet the minimum required standard of English language can complete one of our <u>Pre-Sessional English courses</u> to achieve the required level.
