Choosing your course

All our online courses are listed in CE's online store. Here you will find a course description, fee information and, for more in depth detail, a Course Information Sheet. If you have any specific questions about course content just contact the Online Courses Manager Barbara Hornby.

Who can join our online courses?

We welcome anyone over the age of 16. There are no entrance requirements for our courses and all we ask is that you have a genuine interest in studying the subject.

How to enrol

You can enrol and pay online for all our courses. Just follow the Book a Place Now link on our website.

Data protection

The student enrolment form is used as the basis of our student records. Your date of birth acts as a unique personal identifier on our database and ensures that your details are correct. Information supplied on the form also supports equal opportunities monitoring.

All information supplied is covered by the Data Protection Act. Continuing Education will only use your name and address to provide you with future information about our courses or events. To keep our records up to date, please advise us of any changes to your contact details.

If you do not wish to receive any future mailings from us, please let us know.

Student fees

Fees vary according to the course; please see our website for details. There are no concessionary fees for online courses. However, all online course fees include final assessment and accreditation.

Withdrawal and refunds

If you find that you have to withdraw from a course, you need to e-mail the <u>Online Course Manager</u> a minimum of 7 days before the course start date. No refunds are issued after this date. All refunds are subject to an administrative charge of 10% of the relevant fee.

Course cancellation

In the unlikely event that a course is cancelled a full refund will be made.

Studying, Resources and Support

What to expect

CE will make every effort to:

- Provide an encouraging online environment in which to learn
- Enhance your study experience by promoting the friendly discussion and exchange of ideas
- Equip you to take an active role in your own learning.

A Course Information Sheet is available for all our online courses. This provides information about the syllabus, aims, objectives and assessment. These are available by clicking on the relevant link in each course description in our <u>online store</u>.

All our online courses provide opportunity to submit an assignment for credits which can be accumulated towards a University award.

You can view the technical requirements for studying online with us here.

What we expect from you

Enthusiasm for the subject and respect for lecturers, staff and fellow students are essential requirements.

You should be aware that the University operates an <u>Academic Integrity Policy</u> which is concerned with the ethical code applied to standards by which the academic community operates.

As you are studying at a distance, it is important that you alert us to any problems or queries that you might have as soon as possible. Don't feel that a question is not worth asking – whether it is an academic or administrative issue – it almost always is and it will certainly help us to refine our systems and guidance information.

Structure of the course

Courses are structured as weekly online meetings; interaction with the course tutor and other students takes place in a virtual learning environment called **Blackboard** (at times Blackboard is referred to as <u>VITAL</u> by Academic staff). The courses are designed to fit around your schedule; you access the course whenever it is convenient for you. Occasionally scheduled events are organised, for example a webinar with an invited expert. Most are courses are 6 or 7 weeks in duration with the first week acting as an introduction to the theme and the learning environment and the final week being a summary week. New content will be released at the beginning of weeks 2-5.

Expected hours of study

For a 5 credit course you can expect to do around 10 hours of study per week - although much of this will take place offline and will include reading course books and assignment writing. You will also be expected to contribute to the online discussion forums.

The course assessment will be based on the contributions you make to course discussions and other online forums, plus some form of written work such as an assignment. For your written assignment you may be asked to submit a workbook of answers, an analysis of a case study, a report, or an essay.

Resources

Once you are a registered student of the University a whole world of resources and support opens up to you. Key to using many of these resources is your student ID number. You will find this in an automated email sent to you a few days after your initial payment and course place confirmation. Using this number, visit the 'Your Computing Account' page to generate a username and password which allows you to access the University's computer network.

With your login details you can browse the <u>University Library's</u> online catalogue of print and e-resources. You can also access <u>iLearn</u> which is an online academic skills development resource that has been designed to help you develop the appropriate skills that you need to study successfully at university level.

As a University student you can request a Student Card. Click on this link for <u>Student Card Information</u>. You can generate a card from the <u>Liverpool Life website</u> which also gives you the option to view and update your student details and to download a student transcript. Liverpool Life also keeps you updated with what's new in Continuing Education.

The first time you visit the Liverpool Life website you will be asked to input your student ID number. You will also be asked to choose your own personal password (also called PIN on the system). Whenever you visit the website in the future you will be required to input these details.

Assessment, Credits and University Awards

Active learning

Our courses will engage you, challenge you – and encourage you to take the lead in your own learning. Assessment for credit is optional, but students who take an active role in their learning, and who participate in discussions and activities, are often the ones who get the most out of their course.

Certification and credit transfer

Where could Continuing Education take you?

Credits can be accumulated for a University of Liverpool certificate or used to progress onto a degree programme at Liverpool or elsewhere under the Credit Accumulation and Transfer Scheme (CATS). Note that credit transfer is always subject to the special conditions of each particular university or academic department.

60 credits = Certificate of Achievement in Continuing Education. Whilst this is not a formal award of the University, it is an important recognition of your achievement.

60 credits = Personal and Professional Certificate (PPDC is formally recognized by UOL. For more information, please e-mail the Course Administrator).

120 credits = Certificate in Higher Education (Cert. HE).

You cannot receive credits from the same course more than once. To identify a course always check its unique course code (for example *hist2012* or *phil9011*).

If you are aiming for a University award, retain copies of all assignments completed for credit as they may (rarely) be required by University examiners. Once you have accumulated the required number of credits you should contact the CE office, in writing, with your student number and a list of the relevant course titles, module codes and start dates. Your Certificate will be issued once we have verified that you have achieved the required credits.

Information on assessment

Most 5 credit modules will be assessed by a 1000-1,500 word assignment, although this may vary from module to module; 10 and 20 credit modules generally require more extensive assessment as they carry twice as many credits.

a) Submission guidelines & deadlines

Your lecturer will provide precise instructions about assignments undertaken for credit, including academic expectations and submission date.

If you have difficulty in meeting a deadline you can discuss this with your lecturer in confidence. We realise that Continuing Education students have many calls on their time and can (for the most part) consider sympathetically individuals with mitigating circumstances and requests for extensions.

b) Referencing, plagiarism & collusion

Plagiarism includes a failure to reference sources, close paraphrasing without acknowledgement and, in the most serious cases, copying or downloading another's work verbatim and presenting it as your own. Collusion occurs when there is unauthorised and unacknowledged collaboration. Penalties for plagiarism and collusion vary but could result in serious mark reduction or a mark of 0%.

To avoid plagiarism take good care to reference your work well and completely. Your lecturer will provide guidance or you can find out more <u>here</u>.

c) Marking

Although the way your work is assessed will vary according to subject, the marking criteria applied will always be in accordance with University standards:

70 to 100: Work which provides evidence of good critical analysis and/or an original contribution with a command of data or literature which is either broad or intense.

- 60-69: Work which is thorough, clear and shows evidence of understanding of context and the efficient and competent use of data or literature.
- 50-59: Work in which the treatment of data or literature is basically sound but underdeveloped.
- 40-49: Work that shows some understanding but which offers a basic treatment using a limited range of data and methodologies and arguments which contain some flaws.
- 35-39: Work that fails by a small margin to achieve the standards required for a pass.
- Under 35: Work that is unstructured, ill-presented, contains serious omissions/errors and which fails to demonstrate adequate knowledge, understanding or sustained argument.

Your lecturer will return your assignments to you with your mark and written feedback within 3 weeks of submission.

d) Appeals

If you have concerns about your assignment or marking procedure, in the first instance speak to your course lecturer. If the issue is not resolved at this stage, your lecturer will send your concern on to the academic organiser who will respond according to University guidelines.
