More broadly I am interested in developing integrated school health interventions which support not only children's well-being but also improve school attendance, learning, and attainment. By developing shared language and goals between the health and education sectors, within my research, I aim to ensure we maximize and quantify the benefits of health interventions to support school-age children to achieve their full potential.

The programme thrived during this period, growing to host over 100 clinical studies, 750 staff, 120 postgraduate students and to become the largest research institute in Malawi. As Director, Stephen promoted a culture of excellent translational research, research training, and wide public engagement. He recruited senior scientists to Malawi and nurtured a supportive environment in which junior researchers, particularly Malawians, could plan a career from intern to independent investigator. Stephen has conducted clinical and translational research since 1993 – his research in pulmonary disease in Africa began in 1996. His initial research focus was on HIV-associated lung macrophage functional defects, specifically against pneumonia. He subsequently expanded his interest to include the effect of household air pollution on pulmonary defence including a landmark cook stove intervention trial published in Lancet. During COVID times in Malawi, he and others brought an oxygen plant to QECH, saving many lives now and in the future. His current research focuses on oxygen delivery, and the potential for vaccination to prevent infection. Stephen established a controlled human infection model of pneumococcal carriage in the UK to determine the correlates of protection in the respiratory tract. He has since moved this work to Malawi, the first in Africa, and plans both pneumonia and TB human challenge studies to bring forward vaccine discovery in Malawi. Stephen's particular passion is the CREATOR project – developing postgraduate clinical science



				by developing Clinical Research Excellence And Training in an Open Resource. Stephen's group have established a BCG-CHIM model in LSTM and have recently begun this work in Malawi also.
