The LLM includes a wide range of modules including modules in the fields of Commercial Law; Competition Law, International Business and Trade Law; International Law, Medical Law and Human Rights Law.

Liverpool Law School has strong links to the Legal Profession and to International Organisations.

You should normally hold a minimum of a 2:1 class Honours Degree in Law (BA or LLB), or in a field relevant to the programme you wish to study, from a UK university.

Module Details

All students on our Masters programme study a course on Legal Research Training as preparation for writing their dissertation. The module covers advanced legal research, legal writing, as well as theoretical perspectives and research methodologies.
