Public Lecture

In November 2013, the Charity Law & Policy Unit held its annual public lecture. Sir John Mummery, recently retired Court of Appeal Judge and chair of the Unit's Steering Committee spoke on 'The Charity Experience: Cases, Courts and Counsel'. Sir John entertained a full house which included many students when he spoke about his experiences of being involved in charity cases over the years on both sides of the bench. The lecture has now been published in the *Charity Law & Practice Review.*

International Charity Law Symposium

The Charity Law & Policy Unit held a very successful International Charity Law Symposium here at the University in April 2014. Thanks to support from the Charity Law Association and Key Haven Publications, we were able to invite participants from Australia, Canada, Ireland, USA and of course the UK. Almost 60 people attended from across the country to explore recent international Charity Law developments, focussing on problems and reforms across the common law world. For part of the day, participants (including charity representatives, Charity Law practitioners, academics and postgraduate students) joined one of three workshops in which they discussed similarities and differences in their countries, both in terms of the Charity Law challenges faced and in terms of national responses to these challenges. The three workshops were focussed on charity regulation, charity definition and charity taxation. Papers from the Symposium are due to be published in the Charity Law & Practice Review. Feedback from the day was extremely positive with participants commenting that they had learned a lot from other jurisdictions during the day. The dominant theme was that each country has its own issues to deal with, which make our own seem a little less pressing!

Book Launch

At the close of the International Charity Law Symposium, a reception was held to mark the launch of *Not-for-Profit Law: Theoretical and Comparative Perspectives* edited by Matthew Harding, Ann O'Connell and Miranda Stewart, all of University of Melbourne. Modern Studies in Property Law Conference

Directly preceding the International Charity Law Symposium, the University of Liverpool hosted the 10th Biennial Modern Studies in Property Law Conference. The conference series has its origins in the biennial conference first held by the University of Reading in 1996. Those conferences gave rise to the book, *Modern Studies in Property Law*, which, since 2001, has been the medium for refereed publication of the conference papers by Hart Publishing Ltd. In 2008 the conference took place away from Reading for the first time and was held at Queen's College, Cambridge. In 2010, the conference was hosted at New College, Oxford and in 2012 the conference was held at the University of Southampton. Modern Studies in Property Law 2014 will again be closely tied to publication of the 8th volume of the book, edited by Warren Barr. The event (which included a conference dinner) took place at the Maritime Museum where delegates from countries around the world listened to papers on topics varying from sub-surface ownership to mutual wills and many topics in between. Sir John Mummery gave the keynote address on 'Property in the Information Age'.

A postgraduate conference (organised by John Picton) took place on the final day of the main conference. Alongside providing an opportunity for postgraduate students to present their work in a specialist forum, the programme also included talks on early career advice.

Main conference organiser, Warren Barr, was delighted with both the attendance and the quality of the presentations. Delegates reported that they thoroughly enjoyed the conference, both for the quality of the academic papers and the friendly, Liverpool welcome. Publication of the book is due by the second quarter of 2015.

Changing Cultures

Debra Morris and Warren Barr have been recently been awarded £4,000 from the University of Liverpool's Changing Cultures pump priming fund to begin work on a new project 'The Changing Face of Charity and its Regulation: Capturing the Picture'. The funds will enable Dr Karen Atkinson, who continues to work as a Research Associate for the Unit, to engage in detailed learning about a methodological approach developed outside the social sciences – the systematic review – and to use this methodology in a novel way to conduct a rigorous, cross-disciplinary review of Charity Law, regulation, policy, academic and practitioner literature from the 1960s to the present day.




