### **Public Lectures**

In February 2016, Elizabeth Cooke (Principal Judge, Property Chamber, Land Registration Division and former Law Commissioner) delivered the Unit's annual public lecture. In her lecture, entitled 'Charity Law and the Boundaries of Non-Political Law Reform', Judge Cooke described the process of charity law reform and focused on the new power to be given to charity trustees to make social investments. This power is now contained in section 15 of the Charities (Protection and Social Investment) Act 2016, which came into force on 31<sup>st</sup> July 2016.

Last year saw the Liverpool Law School host the inaugural Property Law lecture, organised jointly with the Liverpool Law School and the Chancery & Commercial Practice Group, Atlantic Chambers Liverpool. Mr Justice Norris, Vice-Chancellor of the County Palatine and Chancery Supervising Judge for the North West spoke eloquently on 'The Poetry of Property: Its Commoditisation and Commercialisation'.

### **Third Sector Research Group**

The first event held by the Group, 'Knowledge Exchange and Collaborative Working: The Third Sector and the University of Liverpool' was held at The Women's Organisation in October 2015, in conjunction with Liverpool Charity and Voluntary Services (LCVS). It attracted over 80 delegates. It launched the working partnership between LCVS, the University of Liverpool and third sector groups within the city of Liverpool and beyond with the aim of improving understanding of the research needs of third sector organisations of varying sizes and the research interests and capacity of University researchers.

The keynote speaker was Karl Wilding, Director of Public Policy at the National Council for Voluntary Organisations (NCVO), who discussed the future research agenda for the sector.

In response to feedback from delegates, some of whom reported a lack of awareness around how to access the University and its significant staff and student resources, the Group held a 'market-place' style event at the University in April 2016, where we showcased various aspects of what the University can do for third sector organisations around the city and beyond. This included representatives from the Guild of Students, initiatives such as Interchange, the University's Business Gateway and other aspects of University life including the Careers and Employability service and Alumni and Philanthropy. During this event, visitors were able to chat with representatives from these key areas of the University to discuss common interests. It also provided an opportunity to network with other third sector groups.

The Group also organised a 'Meet the Researchers' series of early evening events, in which academic colleagues from around the University with research interests in the third sector have briefly and informally presented their ideas and this is followed by group discussion in order to tease out the key issues for the sector around each subject being examined. The series began in May 2016 with 'Perspectives on Social Value' (Dr Jo Meehan and Dr Claire Moxham) and continued through the year with 'Perspectives on Social Housing' (Professor Warren Barr and Dr Jo Meehan) in June, 'Perspectives on Social Health' (Dr Lucy Frith) in July, and 'Perspectives on Social Welfare Law' (Dr James Organ and Dr Jennifer Sigafoos) in September. The final event in this series, 'Perspectives on Social Research in End-of-Life Care' (Dr Pippa Hunter-Jones and Dr Lynn Sudbury-Riley) will be held in October 2016.

## Partnerships, Exchanges, Impact

In June 2016, Warren Barr and Debra Morris provided a full response to the Law Commission consultation exercise on updating the Land Registration Act 2002 and we are awaiting the Law Commission's forthcoming report and draft bill.

In the same month, Debra Morris was invited to present before a private meeting of the newly established House of Lords Select Committee on Charities, during which invited participants set

> out key issues for the Committee to consider as part of its inquiry. In September 2016, Unit members submitted a joint response to the wide-ranging consultation issued by the House of Lords Select Committee on Charities. We await the outcome of the consultation.

Debra Morris's work with the Kent Law School regulation of bingo project drew to a close. She has acted as a member of this ESRC funded project's Advisory Board for the last three years. The project culminated with a conference in June 2016, together with a launch of the project's final report. The report can be downloaded here.

Together with James Organ, Jennifer Sigafoos has been partnering with Merseyside advice agencies to continue a research project into the effects of legal aid cuts and austerity measures on local social welfare advice. The project began through the award of a Knowledge Exchange Voucher and this part of the project was led by Debra Morris in 2013. In 2015, Jennifer and James followed up this work. They surveyed local advice workers, interviewed advice agency heads and conducted a focus group. Jennifer is continuing fieldwork to get a national perspective, and additionally Jennifer and James are conducting three further focus groups with advice agency staff on meeting unmet need. The project has been identified as a potential impact case study within the Department for REF2020. Jennifer and James wrote a report of the findings for a policy audience for the agencies to present to the Liverpool City Council in January 2016, in advance of meetings regarding 2016-17 funding. They also submitted written evidence about this project to the Bach Commission Call for Evidence about Legal Aid Cuts.
