# Alcohol policy scoring

- How do we rate the implementation of the European action plan to reduce the harmful use of alcohol?
- Has the alcohol policy environment in a certain country become stricter or more relaxed over time?
- How is the European region faring in terms of alcohol control?
- How can we convince stakeholders that more needs to be done to reduce alcohol-related harm?

A composite index that captures **overall completeness** of national alcohol strategies One country → One score (per action area)



### **Overarching Framework**

- European action plan to reduce the harmful use of alcohol 2012-2020
- 1) Leadership, awareness and commitment
- 2) Health services' response
- 3) Community and workplace action
- 4) Drink-driving policies and countermeasures
- 5) Availability of alcohol
- 6) Marketing of alcoholic beverages

# Scoring Scheme: Raw Scores

- Tiers introduced to reflect different degrees of a policy attribute
  - Strictness (e.g. legal age limits) and comprehensiveness (e.g. scope of monitoring system)

Does not exist but is being developed	1

implementation	

# Scoring Scheme: Weighted Scores

Multiplier levels attached to indicators depending on level of effectiveness

	Definition
5x	High level of effectiveness demonstrated consistently across different populations OR Fundamental public health infrastructure needed to initiate and sustain an effective response
4x	High level of effectiveness demonstrated in a limited number of studies and populations OR Moderate effectiveness demonstrated consistently across different populations
3x	Moderate effectiveness demonstrated in a limited number of studies and populations
2x	Limited effectiveness OR Insufficient evidence to conclude degree of effectiveness
1x	Not shown on its own to be effective but may be valuable as part of a package of policy measures




## **Pricing policies**

	Max raw score	Multiplier level	Weighted score
Adjustment of taxation level for inflation	4	3	12
Affordability of alcoholic beverages	4	4	16
Other price measures (MuP, additional levy on specific products, non-alcohol cheaper than alcohol, ban on below-cost selling, ban on volume discounts	14	3	42




### Conclusion

# The composite indicator(s) will provide a rounded evaluation of national alcohol strategies.

- How do we rate the implementation of the European action plan to reduce the harmful use of alcohol?
  - Facilitates a simple way to monitor country progress over time in the 10 action areas
- Has the alcohol policy environment in a certain country become stricter or more relaxed over time?
  - Facilitates internal benchmarking monitoring country progress over time
- How is the European region faring in terms of alcohol control?
  - Facilitates external benchmarking can also compare countries/regions
- How can we convince stakeholders that more needs to be done to reduce alcohol-related harm?
  - Simplifies communication big picture view is easier to grasp than separate trends across different indicators
