1. Access the CIBC International Student Pay platform

Access the [CIBC portal](#) or visit "Paying your fees through CIBC International Student Pay" page on the University of Liverpool's website.

2. Enter your home country and payment amount

Enter the total tuition or student fees in Great Britain Pound (GBP), then identify your home country. You'll be shown the amount you'll be paying in your home or your preferred currency at CIBC's competitive exchange rate.

3. Provide details and select your preferred method of payment

Enter a few student and payee details and choose from an ever-evolving suite of payment methods including Bank Wire, e-Wallets and Pre-Authorized payments. Click SUBMIT to initiate or complete your payment via your preferred method.

4. Receive payment instructions

- Include **Payer's full name**
- Ensure the **Payer's complete address** is included—**house number, street name, locality, city, 6-digit pin code, state, and country**
- Payment should be made from the **Local Bank Branch of the payer** as opposed to online RTGS/NEFT transfer
- Ensure that "**FEMA Checks Done**" is to be captured under **Remittance information**
- A confirmation with your transaction details will be sent to you by email

5. Track online

Track your payment status online anytime and receive email alerts along the way.

Your job is done! You will receive a confirmation email as soon as your payment has been received so that you know the transaction is complete.
